## **General Rules**

- 1. Any grants or scholarships made through the JIB Fund are discretionary and in accordance with Skills Development Fund Trust Deed.
- 2. Grants will be paid to a maximum of 75% of the course fee. Courses are capped at different amounts for different course levels. Level 3 courses attract funding of up to £750 per year, Level 4 and 5 courses up to £1000 per year and Level 6 courses up to £1250 per year. Grants for unemployed operatives will be at the discretion of the Committee.
  - The Skills Development Fund Committee can award grants or scholarships to enable apprentices and adults to attend courses or receive instruction in subjects related to the electrical contracting industry, for travelling and research in connection with the study and development of subjects related to the electrical contracting industry or for the general promotion of further education and advancement in the electrical contracting industry.
- 3. The JIB will also consider applications from individuals who wish to undertake a valid research project which will be of benefit to the electrical contracting industry as a whole.
- 4. Invoices/receipts or any other proof as required by the JIB will be submitted to the JIB.
- 5. The Skills Development Fund is unable to pay grants in advance of course registration and the appropriate payment being made to the relevant college or training provider. You will need to provide receipts or proof of payment in order to receive a grant. Alternatively, once an individual is registered onto an eligible course the charity can make payment to the college or training provider directly to reduce the cost of the course. Proof of registration will be required.
- 6. Applications for a grant are ONLY available to JIB graded operatives participating in the JIB Benefits Scheme working for a JIB Member Company, registered apprentices and unemployed registered operatives holding a valid ECS card. Discretion lies with the Trustees.
- 7. The JIB may close the fund at any time.
- 8. The JIB reserves the right to alter the level of funding at any time.
- 9. The annual funding year will run from 1st June to 31st May.
- 10. The Committee's decision will be final.

## **Notes**

- (i) Other courses which have not been approved previously by the Committee will be considered for funding and will be dealt with on a case by case basis.
- (ii) The JIB Skills Development Fund also provides a Scholarship Grant of up to £3000 to operatives undertaking courses at a Masters level as a minimum (e.g. MA, MSc, LLM). To be eligible an applicant must be employed by a JIB member company or be registered as unemployed, and must be graded as an Approved Electrician or above.
