

The JIB Skills Development Fund





Grants of **up to 75%** of course fees to support education and training

Who may be eligible?

- Those employed by a JIB member under the JIB Agreement.
- Apprentices registered with the JIB.
- Operatives who are unemployed will also be considered.

How to Apply

Funding is provided directly to the college or training centre or is reimbursed to the operative (or their company) on the production of proof of payment.

Which courses are covered?

Level 3 Courses – up to £750 per person per funding year.

Including: Continuing Professional Development (CPD) courses for qualified electricians - such as EV Charge Point Installation and Maintenance; Solar PV; and routes to gold card such as Experienced Worker Assessments (EWAs).

Level 4–5 Courses – up to £1,000 per person per funding year.

Including: HNCs/HNDs in subjects such as Building Services or Electrical and Electronic Engineering; Design and Verification of Electrical Installations and the EWA in Building Energy Management Systems.

Level 6 Courses and above – Up to £1,250 per person per funding year.

Degrees and postgraduate courses.

The Paul Corby Bursary

Up to £5,000 per person.

This is a discretionary award recognising exceptional talent and accomplishment, to offset costs for those undertaking a degree or postgraduate course.

Other Level 4 and 5 courses

Including Design and Verification of Electrical Installations

Level 6 Courses and above

Including:

Degree level qualifications or postgraduate courses. Up to £1,250 per person per funding year.

Paul Corby Bursary

Operatives considering undertaking a Level 6 or higher qualification, such as a bachelor's degree or master's degree, may apply for the Paul Corby Bursary. Applications are considered on merit and it may be awarded to more than one individual in the funding year.

- AM2 / AM2S / AM2D / AM2E
- BS7671 IET Wiring Regulations
- CompEx courses
- Inspection and Testing (e.g. C&G 2391)
- IOSH / NEBOSH / SSSTS / SMSTS or other H&S certificates.
